CUSTOMS COMPLIANCE

In a recent blog issued by the British Chambers of Commerce last week, NEW UK border checks for goods moving have become more rigorous since January 2022 and the UK Government, via HMRC have begun enforcement of the rules that need to be applied now that Staged Customs Controls have come to an end.

Penalties of up to £2,500 per error up to a maximum of £10,000, and even criminal prosecution. Your company could be flagged as a non-compliant operator.
